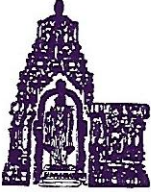

APPEAL FOR FINANCIAL ASSISTANCE

- 1. With the cooperation of devotee public, the Samaj has been able to complete the cover for the open courtyard between Sree Meenakshi-Sundareswarar temple and Pravachana (Kalyana) Mandapam. This provides protection against sun, rain and severe weather conditions.**
- 2. Construction of an enchanting Dwara Vimanam at the Western entry of the temple with divine statues of Gods, established at the top, has been completed. Fixation of a strong iron gate and pavement work at the ground level at the entrance has been completed and has also been opened for public.**
- 3. Work on the expansion, reconstruction and renovation of the second prakaram has been completed. The construction of an artistic shed to provide shelter to the Golden Chariot has also been completed.**
- 4. The Management is happy to inform the devotee public that the long-awaited Golden Chariot (Thanga Ratham) for Lord Swaminatha Swami with Lord Swaminatha Swami Utsava Moorthi seated in it had started running over the renovated second prakaram on the auspicious Sunday, the 1st April 2018 at 6.15 p.m.**
- 5. Renovation of existing Navagraha Temple has been undertaken and is expected to be completed shortly.**
- 6. It may be noted that amount donated for the renovation and repair of Sree Swaminatha Swami temple qualifies for rebate under Section 80G(2)(b) of the Income Tax Act, 1961.**
